PROJECT DESCRIPTION: Proposal for a new restaurant in the Appealable Jurisdiction of the Coastal Zone. Project includes the conversion of an existing fabrication shop to a new 2,521 square-foot restaurant and bar, remodel of the existing front facade, construction of a new 1,834 square-foot dining patio, new trash enclosure, and reconfiguration of the existing parking lot. Planning Commission review is required for a Coastal Development Permit.
