PROJECT DESCRIPTION: Proposal for an over-height retaining wall and fence on a site with an approved 17 unit affordable housing project. Prior approvals on site include a 17 unit, two- and three-story structure including a 589 square foot community center, 387 square foot, two-story manager's unit with attached one-car carport, a 234 square foot manager's office, 89 square foot laundry facility, and trash enclosure. The current application is for a retaining wall with a maximum height of 7'-1" with an additional 6'-0" foot tall fence on top, running the length of the north and east property lines. Staff Hearing Officer review is required for a Zoning Modification for the over-height retaining wall and fence.
