NOTICE OF A PUBLIC HEARING: ARCHITECTURAL BOARD OF REVIEW (ABR)

PROJECT DESCRIPTION: Proposal for a four unit residential project to be developed using the Average Unit-Size Density (AUD) Program. Project consists of the demolition of all structures on site, and the construction of two, two-story duplexes. Unit mix will include three, 2-bedroom and one studio apartments ranging in size from 487 to 1,215 square feet with an average unit size of 867 square feet. The proposed density on this 7,250 square foot lot is 25 dwelling units per acre, on a parcel with a General Plan Land Use Designation of Medium-High Density which allows for 15-27 dwelling units per acre. Also proposed are four covered parking spaces and changes to the on-site landscaping. A Minor Zoning Exception for an over-height fence is requested for a site wall plus fencing to be 9.5' in height instead of the maximum of 8' in height allowed.
