PROJECT DESCRIPTION: Proposal for an addition and new patio within an existing residential development. Project proposes renovating the existing dining room and adding an additional 2,350 square feet. Also proposed are changes to the landscaping, construction of a trellis/shade structure, installation of accent pavers, outdoor seating, new fireplace, and walkways with benches. The use was approved under a CUP per PC Reso 011-95. Project requires a Level 2 Substantial Conformance Determination (SCD) from the Planning Commission. No additional residential units are proposed.
