PROJECT DESCRIPTION: Proposal to reconfigure areas within the parking lot of the YMCA. Project consists of the addition of 37 new parking spaces, removal of existing hardscape and landscaping to accommodate new parking, removal and replacement of 16 trees, removal of walls and fencing, and the installation of new landscaping, irrigation, and permeable paving.
