PROJECT DESCRIPTION: Proposal for a new masonry flood wall in the Appeal Jurisdiction of the Coastal Zone. Project entails replacing an existing chain link fence around the perimeter of the District facilities with a new 3-foot high reinforced masonry flood wall. Proposed wall to be installed with 3-foot iron posts with "spear tops" to serve as security fencing. The combined height of the wall and posts is 6 feet. Vehicular and pedestrian gate entrances to the site will be fitted for removable metal flood walls. Planning Commission review is required for a Coastal Development Permit.
