PROJECT DESCRIPTION: Proposal for a new non-residential structure and staging area. Project entails the demolition of all structures on site and the construction of a new 3,151 square foot, single story industrial structure. The project also proposes two staging areas for equipment and vehicles, new trash enclosure, perimeter planters, and storm water basin. Five parking spaces are proposed.
