PROJECT DESCRIPTION: Proposal to alter an existing single story 928 square foot residential unit and create an additional residential unit. The project includes a 19 square foot addition and would result in a two unit duplex with one 474 square feet unit and one 473 square feet unit. The existing one covered and one uncovered parking spaces would remain.

All public comments submitted via email will be provided to the Board and will become part of the public record. However, please be advised, correspondence sent via USPS may not be received in time to process prior to the meeting and email submissions are highly encouraged.
