PROJECT DESCRIPTION: This is a One-Time Pre-Application Consultation to receive feedback on a proposal for a new permeable paver patio enclosed with a 5'-0" tempered glass wind screen and associated improvements located in the 10'-0" Milpas Street Widening Setback. The project includes a new planter surrounding the patio, door, relocation of a fence and gate, and accessibility improvements including ADA ingress/egress ramps with handrails, and striping for an existing ADA space. This project will require City Council approval of a Variance for improvements in the 10'-0" Milpas Street Widening Setback and a Front Setback Modification for improvements and alterations within the required 20'-0" front setback. Hotel improvements that are outside of the Milpas Street Widening Setback are under PLN2020-00603.
