NOTICE OF A PUBLIC HEARING: Architectural Board of Review (ABR) Consent

PROJECT DESCRIPTION: The proposal includes permanent legalization of an outdoor dining deck that was approved under Emergency Ordinance No. 5944 (pertaining to Covid-19 Economic Recovery) within the required Front Setback of the subject parcel, as well as construction of a retractable awning over the deck and glass walls surrounding the deck. An existing ground sign is proposed for removal; replacement and relocation will occur under a separate permit. Infilling the patio surface to accommodate the ground sign removal is also proposed. The project requires review of a Front Setback Zoning Modification by the Staff Hearing Officer.

You can also select the option to use your telephone, but you must use the GoToWebinar software to interact with the meeting. Select "Use Telephone" after joining the webinar and call in using the numbers listed on the agenda that will be posted online. Oral comments during a meeting may be made by electronic participation only.

WRITTEN PUBLIC COMMENT: Public comments may also be submitted via email to ABRSecretary@SantaBarbaraCA.gov prior to the beginning of the Meeting. All public comments submitted via email will be provided to the Board and will become part of the public record. You may also submit written correspondence via US Postal Service (USPS); addressed to ABR Secretary, PO Box 1990, Santa Barbara, CA 93102-1990. However, please be advised, correspondence sent via USPS may not be received in time to process prior to the meeting and email submissions are highly encouraged.

ADDITIONAL INFORMATION: The scope of this project may be modified under further review. To be informed of future hearings, you may (1) Submit a request electronically to become an "Interested Party" for notification by email when the project is scheduled on an agenda. Agendas are posted and emailed to interested parties 72 hours before the meeting. (2) Join the City's SantaBarbaraCA.gov/MySB to subscribe to email notification whenever ABR agendas posted. This is a general subscription to all ABR agendas. You may also contact City Planning staff at (805) 564-5578 for questions on a case.
