PROJECT DESCRIPTION: The project consists of permitting an as-built three-car carport located on a 6,065 square foot lot. It is located between a two-story single residential unit at the front, and a one-story single residential unit at the rear of the site. The project requires review of an Open Yard Zoning Modification by the Staff Hearing Officer to allow a reduction of required open yard.
