NOTICE OF A PUBLIC HEARING: Architectural Board of Review (ABR) Consent

PROJECT DESCRIPTION: Proposal to permit two “as-built” residential units and convert two existing commercial suites into two new residential units for a total of four residential units on the second story. There are 11 uncovered and 6 covered existing parking spaces on the site. The project also includes commercial and residential bike parking, the conversion of an existing bathroom into new storage and laundry room, new rooftop mechanical equipment screening, and a new trash enclosure with 5-foot wooden screening fence. Review and approval of a Zoning Modification by the Staff Hearing Officer is required to reduce and alter the Open Yard requirement.

Oral comments during a meeting may be made by electronic participation only.

WRITTEN PUBLIC COMMENT: Public comments may also be submitted via email to ABRSecretary@SantaBarbaraCA.gov prior to the beginning of the Meeting. All public comments submitted via email will be provided to the Board and will become part of the public record. You may also submit written correspondence via US Postal Service (USPS); addressed to ABR Secretary, PO Box 1990, Santa Barbara, CA 93102-1990. However, please be advised, correspondence sent via USPS may not be received in time to process prior to the meeting and email submissions are highly encouraged.

ADDITIONAL INFORMATION: The scope of this project may be modified under further review. To be informed of future hearings, you may (1) Submit a request electronically to become an "Interested Party" for notification by email when the project is scheduled on an agenda. Agendas are posted and emailed to interested parties 72 hours before the meeting. (2) Join the City's SantaBarbaraCA.gov/MySB to subscribe to email notification whenever ABR agendas posted. This is a general subscription to all ABR agendas. You may also contact City Planning staff at (805) 564-5578 for questions on a case.
