NOTICE OF A PUBLIC HEARING: Architectural Board of Review (ABR)

APPLICANT/OWNER: Sherry & Associates, Architects / 518 Haley Partnership LLC

PROJECT DESCRIPTION: The existing site is developed with an 8,204-square-foot commercial building on the first floor and 883-square-foot office on the second floor. Proposal to address violations outlined in ENF2017-01321, permitting the conversion of the commercial office on the second floor to a residential unit. Exterior improvements include a new access stair and entrance to the residential unit, alterations to windows, and installing a hedge border at the proposed upper level deck. Project includes removal of an unpermitted interior upper level office at the rear of the warehouse. Eighteen parking spaces are located offsite on an adjacent lot and will be restriped as part of the project. Staff Hearing Officer review and approval is required for an Open Yard Modification to allow the open yard to be located on the upper level roof deck.
