NOTICE OF A PUBLIC HEARING: Architectural Board of Review (ABR)

PROJECT DESCRIPTION: A new concrete-surfaced storage yard for equipment and vehicles on the existing vacant site. Most existing trees are proposed to be removed and new trees are proposed. The project is adjacent to El Estero Drainage and proposes wetland delineation and habitat restoration, two bioretention basins, as well as additional remediation of contaminated soil. Proposed grading quantity is approximately 2,530 cubic yards of cut and 120 cubic yards of fill. The project requires Planning Commission approval of a Coastal Development Permit.
