PROJECT DESCRIPTION: Proposal for improvements and accessibility upgrades to the Blue Sands Inn. Project includes exterior alterations to the hotel structure including a new stair tower; site improvements including changes to landscaping and the pool area, and a new exterior patio along Milpas Street; and miscellaneous interior upgrades including converting the manager's bedroom to a hotel room. Staff Hearing Officer approval of a Front Setback Modification and Coastal Development Permit was granted on September 22, 2021.
