NOTICE OF A PUBLIC HEARING: Architectural Board of Review (ABR) Consent

PROJECT DESCRIPTION: The existing site is developed with a single-story residence, and two-story building comprised of a two-car garage at the lower floor and residential unit at the second floor. Proposal to permit the as-built conversion of a portion of the garage to a 300-square-foot Accessory Dwelling Unit (ADU). The remaining lower floor area would be comprised of a 273-square-foot one-car garage and 135-square-foot storage space. Exterior improvements are limited to retention of one of the garage roll-up doors which will no longer access parking, and permitting as-built fencing. Staff Hearing Officer review and approval of a Parking Modification is required to allow the as-built conversion of one of the covered parking spaces to storage.
