**PROJECT DESCRIPTION:** The project consists of the reconfiguration of the rental car parking lot, and the addition of three new Remain-Over-Night parking spaces for large commercial aircraft at the Santa Barbara Airport. A large existing hangar and existing parking lot is proposed to be demolished and repaved, along with landscaping, fencing, and lighting alterations. The project requires Planning Commission approval of a Coastal Development Permit.
