**PROJECT DESCRIPTION:** Proposal for a new multi-unit residence using the Average Unit-Size Density (AUD) program. Project entails conversion of the existing three apartment units into four units by adding a new 2 bedroom (unit B) above a new attached 4 car garage. The project includes a 200 square foot addition to connect units C and D as a duplex. The result would be four residential units ranging in size from 882 to 1,043 square feet with an average unit size of 933 square feet. The proposed density on this 10,041 square foot lot is 17 dwelling units per acre on a parcel with a General Plan Land Use Designation of Commercial Industrial-Medium High Density Residential which allows between 15-27 dwelling units per acre. The proposal includes a new trash and recycling enclosure and 4 new bike lockers. The development would have 4 covered parking spaces.
