PROJECT DESCRIPTION: The project consists of a new three-story development on a 0.5-acre vacant lot located at the southwest corner of Anacapa Street and E. Mason Street. The proposal includes an airspace condominium map for development of one building consisting of two small, six-room hotels, corner market/bodega, various types of restaurants (sit down, coffee shop, and fast casual kitchens), a tasting room, artist studios, an art gallery, and other retail space. The project would require a Parking Modification (SBMC §28.92.110); Coastal Development Permit (SBMC §28.44.060); Development Plan (SBMC Chapter 28.85); two Conditional Use Permits (SBMC Chapter 28.94 and 28.71.030); and a Tentative Subdivision Map (SBMC Chapter 27.07).
