NOTICE OF A PUBLIC HEARING: Architectural Board of Review (ABR)

PROJECT DESCRIPTION: The project consists of demolition of all on-site structures and construction of a 33-unit multi-unit family apartment complex with rooftop amenities. Consistent with the City's Average Unit-Size Density (AUD) Program, the City's Inclusionary Housing Ordinance and the State's Density Bonus Law, there will be: two (2) Moderate-Income units, five (5) Low-Income Units, and twenty six (26) market rate units. No parking is proposed on-site, consistent with the AUD Ordinance. The project is proposed at a density of 86.84 units/acre, which is allowable with the State Density Bonus Law.
