**PROJECT DESCRIPTION:** This project involves two properties: 710 E Cota and 712 E Cota. Proposal to demolish 1 single family dwelling and garage structure on each lot, and construct a 3-story, 3-unit building on each lot, each with 3 covered parking spaces. Shared parking access is proposed. This would result in a 6-unit development with 6 parking spaces. The units would have an average unit size of 1,242 square feet with a density of 26.1 units per acre. Site grade would be built up to construct units above the Design Flood Elevation.
