NOTICE OF A PUBLIC HEARING: Architectural Board of Review (ABR)

PROJECT LOCATION: 201 E Haley, **ZONE:** M-C (Manufacturing Commercial), **GENERAL PLAN:** Commercial Industrial-Medium High Density Residential (15-27 units/acre)/Priority Housing Overlay (37-63 units/acre), **APN:** 031-202-016, **PRE** 2021-00211,

APPLICANT/OWNER: Morgan Krapes, Flowers and Associates, Inc./Tony Mancuso, CFO, Mission Linen Supply

PROJECT DESCRIPTION: The project consists of constructing a 34,650 square foot, four-story, 48-unit mixed-use building, comprised of 8 studio units, 32 one-bedroom units, 8 two-bedroom units and approximately 6,632 square feet of commercial retail space on the ground level intended for 5-7 businesses. The residential units range in size from 428 square feet to 744 square feet with an average unit size of 587 square feet. Rooftop pool, gym and amenities are proposed as well as grading and landscaping. 63 vehicle parking spaces and 52 bicycle parking spaces are proposed. The project site is a 26,771 square foot vacant lot, and proposed development would be 78 dwelling units per acre. The project is designed to comply with the City's Average Unit Size Density Incentive (AUD) Program (SBMC Chapter §30.150), California State Density Bonus Program (CA Gov. Code §65915-65918), and the Streamlined Housing Project Program (CA State Senate Bill 330). Development Plan Approval at Planning Commission is required for the project.
