**PROJECT LOCATION:** 8 Ocean View Avenue, **ZONE:** R-2/S-D-3, **APN:** 015-292-013 AND 015-292-014, **PLN** 2021-00478

**PROJECT DESCRIPTION:** The project consists of a voluntary lot merger of APNs 015-292-013 and 015-292-014 and demolition of all structures on those two lots, including a single family residence, detached garage, and two accessory buildings. One fruit tree and three palm trees are also proposed for removal. One single family residence, two duplexes, and two detached Special Accessory Dwelling Units are proposed, for a total of seven (7) units, five (5) of which are considered primary units and two (2) of which are accessory units. Fourteen (14) uncovered vehicle parking spaces (including 2 electric vehicle charging spaces), seven (7) bike lockers, and a trash enclosure are also proposed. At a future hearing, the Staff Hearing Officer will review a <u>Coastal Development Permit</u> (CDP2021-00022) to allow the proposed development in the Non-Appealable Jurisdiction of the City's Coastal Zone (SBMC §28.44.060). The purpose of this hearing is to receive conceptual design review comments from the Architectural Board of Review.
