Cars Are Basic, Inc. (CAB) has serious concern regarding the ongoing closing of State St. in Old Town an moves to narrow / remove street capacity.

In the past two decades CAB has had Financial advisors, Ph.D. Economist, and local business owners, who have clearly stated the adverse Long Range economics of constricted transportation grids. One only has to look at the 4 decade decline of Down Town Santa Barbara, and both the plans and intent to change a 100 year old "working" transportation plan to see the truth of this statement. A basic Economic Geography course at SBCC and CSULB confirmed the need for a flowing transportation in modern society, "IF" you want a long term economic success.

#### Street Grid

One only has to look at the failures of Detroit, Baltimore, and other high density inner cities to affirm their eventual failures. Comparing Santa Barbara Downtown to the successes of Goleta confirms aspects of successful economics. Recently multiple former Santa Barbara Councilmen have spoken out against this ongoing planning that destroys free flowing transportation and parking.

The past decade current planning favoring high density ignores these failures. The History Channel aired a 2 part transportation analysis transportation options. The outcome clearly stated at the end of their program is; after over a hundred years of experiments and failures what the current modern transportation grid proves (lights, intersections, capacity, parking, no roundabouts,etc.) is what "works."

The "density" planners are the latest "flavor of the month" concept. They ignore reality and outcomes mentioned above.

## Financial Impacts

Financial Multiplier for "events" is critical for most of Santa Barbara. It is the "carryover" that provides the "needed" profit businesses need to sustain themselves year in and year out. To be clear the "financial multiplier" is what happens with every dollar spent during an event to support the community and support businesses in an economy.

In the 1960's the multiplier was approximately \$10.00 for every dollar spent. In today's inflated economy the multiplier is approximately \$25.00 for every dollar spent. There are historically 5 parades that are important to Santa Barbara's economy because they are broadly spread over downtown. (Solstice, 4 July, Fiesta, Veterans Day, and Christmas) They are draws for people to downtown. Not just the Beach, or a park, but to the entire Old Town. Down Town needs this. Without these special events impacting broader the geographical area you will see a continued decline. Without a vibrant and efficient street grid you will see a continued decline.

CAB strongly urges you to a) include this in the final debate over State St. discussion, and b) re-open this vital and significant street that carried 20,000 car trips a day prior to the pandemic.
