

RESOLUTION NO. 19-061

A RESOLUTION OF THE COUNCIL OF THE CITY OF SANTA BARBARA AMENDING RESOLUTION NO. 19-039 TO REVISE PLANNING FEES FOR NEW MULTI-UNIT RESIDENTIAL (5–20 UNITS), CONSENT OR MINOR COASTAL DEVELOPMENT PERMIT, NEGATIVE DECLARATION PREPARED BY STAFF, AND VOLUNTARY PRT REVIEW; AND TO ADD LANGUAGE TO IDENTIFY THE FEE TO BE CHARGED FOR A PROJECT THAT QUALIFIES FOR MINISTERIAL STREAMLINE REVIEW UNDER SENATE BILL 35 (GOVERNMENT CODE §65913.4).

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SANTA BARBARA AS FOLLOWS:

SECTION 1. Resolution No. 19-039, establishing certain City fees, is hereby amended by revising Planning Fees for New Multi-Unit Residential (5 – 20 Units), Consent or Minor Coastal Development Permit, Negative Declaration Prepared by Staff, and Voluntary PRT Review; and to Add Language to Identify the Fee to be Charged for a Project that Qualifies for Ministerial Streamline Review Under Senate Bill 35 (Government Code §65913.4).


