

RESOLUTION NO. 08-111

A RESOLUTION OF THE COUNCIL OF THE CITY OF SANTA BARBARA AMENDING RESOLUTION NO. 08-060, ESTABLISHING CERTAIN CITY FEES, INCLUDING WATER AND WASTEWATER RATES, AND RESCINDING RESOLUTION NOS. 07-052, 07-085, AND 08-013, BY ADJUSTING DOWNTOWN PARKING HOURS FOR WHICH FEES ARE IN EFFECT, EFFECTIVE FEBRUARY 1, 2009

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SANTA BARBARA AS FOLLOWS:

SECTION 1. Resolution No. 08-060, establishing certain City fees, including water and wastewater rates, and rescinding resolution nos. 07-052, 07-085 and 08-013, is hereby amended by adjusting Downtown Parking Hours for which Fees are in effect, effective February 1, 2009.

Downtown Parking Lot charges are effective between the hours of:

- 7:30 a.m. and 9:00 p.m., ~~Monday~~ Sunday through Thursday
- Friday: 7:30 a.m. to ~~4:15 a.m.~~ 2:00 a.m. Saturday morning

- and Thursday of Fiesta 7:30 a.m. to 2:00 a.m. Friday morning.

SECTION 2. Resolution No. 08-060, establishing certain City fees, including water and wastewater rates, and rescinding resolution nos. 07-052, 07-085 and 08-013, is hereby amended by adding the parking penalty for Santa Barbara Municipal Code Section 10.44.205, effective upon approval by City Council.
