1. Approve Minutes of February 25, 2014 meeting.

#### STAFF REPORTS/DISCUSSION

1. Update from FY 2013/2014 CDBG Capital project grantees requiring extension beyond April 30, 2014.

Adam Hendel from the Public Works Department reported that progress has been made to the Access Ramps project, the concrete has been installed and that the next steps include installation of ADA-required tactile warning bumps and painting. The project will require a short extension beyond April 30.

Cynthia Boche from the Metropolitan Transit District reported that an extension was required due to unexpected permitting delays, but MTD has spent 89% of the grant funds to date. The project is expected to be completed by mid-June.

Ricardo Venegas from the Parks and Recreation Department reported that the Franklin Center Rehabilitation project was delayed because the safety glass manufacturer sent the wrong size glass. The safety glass was installed and now the project is waiting for the ordered cabinets to arrive.

2. Discussion of City Council action on subcommittee recommendations for FY 2014/2015 CDBG and Human Services funding.

Staff provided an update on the March 25 City Council meeting: Council approved the committee's recommendations as presented, despite protests from one unfunded agency.

3. Discussion on the format of grantee performance reports.

The committee and staff discussed options on making the new performance reports easier to understand. It was a suggested that a subcommittee be formed to establish performance report criteria.

4. HUD Annual Action Plan timeline and update.

Staff reported that the Draft Action Plan was available for public review until May 8.

5. Discussion/Action to cancel the May 27, 2014 CDHSC meeting.

Due to lack of quorum, a vote could not be held on this item. Staff will ask for availability to attend the May 27 meeting.
