#### STAFF REPORTS/DISCUSSION

1. Action Item: Consider and vote on the request from Girls Incorporated to amend its FY 2014-15 CDBG capital grant from restroom rehabilitation to roof replacement at the Ortega Street Center.

*Girls Inc. Executive Director Monica Spear gave a presentation on the need to amend the CDBG grant from restroom rehabilitation to roof replacement. After a discussion the committee voted to amend the agreement by majority voice vote. (M-Faulstich/S-Ramirez)*

2. Public hearing seeking input on the 2013-2014 Consolidated Annual Performance Evaluation Report to the Department of Housing and Urban Development (HUD).

*Staff gave a report on the accomplishments of the CDBG program for Fiscal Year 2013-14. The chair then opened the item for public comment: Crucito Cruz commented that with the loss of the Redevelopment Agency the City has to identify other funding sources to continue supporting service-providing organizations.*

3. Needs Assessment public hearing to assist with development of the City's 2015-2019 Consolidated Plan and 2015-16 Annual Action Plan to HUD.

*Staff explained that the City is currently developing a HUD-mandated 5-year strategy for use of CDBG funds. As such the City is required to hold a public Needs Assessment. The chair then opened up the discussion to public comment: Carolyn Brown spoke of the need to prioritize youth education programs. Lisa Brabo spoke of the need for the continued allocation of public funds to service-providing organizations to help them leverage private funds.*
