1. Consolidated Annual Performance Evaluation Report Public Hearing

Staff gave a brief presentation on the City's performance during FY 2016-17 and the public hearing was held.

2. Needs Assessment Public Hearing

Staff gave a brief presentation on the City's Consolidated Plan goals in preparation for the FY 2018-19 funding cycle and the public hearing was held. The committee discussed amending the City's funding priorities — specifically language regarding programs that serve gang-involved youth. A subcommittee will be formed after the funding cycle is completed to develop new Priority 1 language to recommend to Council.
