### **Transient Occupancy Tax Results for the City of Santa Barbara**

**SANTA BARBARA, CA – October 25, 2019**

The City of Santa Barbara collected approximately \$1.93 million in transient occupancy taxes (TOT) for September 2019, which is 4.2% above September of last year.

Through September 30, the City has collected approximately \$6.7 million in TOT revenues for fiscal year 2020, which runs from July 1 through June 30. The City's adopted TOT budget is \$19,989,179.
