8. FIRE CHIEF'S REPORT

From Division Chief McElroy, who provided handouts on incident statistics.

- Retirements: Fire Chief DiMizio retires 12/14/12 after 38 years in the fire service. Captain Fierro also retires on 12/14/12, and Engineer Homburg retires on 12/30/12.
- About 60 Firefighter-Lateral interviews took place last week. There are 13 finalists who
 will proceed in the hiring process. 8 position openings are projected. The pension
 reform changes will have an impact on who accepts a job offer.
- Promotions: Anticipating promoting 1 Captain and 2 Engineers by early spring.
- MOBEX Exercise A large mobilization exercise was conducted on 12/4 at the
 Devereux property in Goleta. The scenario was a building collapse responded to in real
 time by several area agencies. Captains Pighetti and Turner were commended for
 organizing the exercise.
- Average response time remains under 3 minutes.
- The number of responses for the year will be around 8,000 calls.

9. POLICE CHIEF'S REPORT

From Deputy Chief Mannix:

- 8 cadets are in week 6 of the academy. They are progressing well and all should be able to complete the program.
- An in-car video system has been funded. Interview rooms will also be retrofitted with the same system.
- 3 retirees: Lt. Doug Kresky, Police Officer Steve Robles, and Sgt. Marty Ensign.
- Open entry testing and oral boards are currently being conducted.
- Significant calls:
 - 11/25 7:30 PM Man shot and is currently in critical condition. The investigation is continuing.
 - 11/16 518 N. Milpas, La Pachanga nightclub. An ABC raid resulted in the closure of the business, and arrests including drug possession.
 - o 12/6 A month long investigation resulted in a narcotic arrest for ¼ lb. of Meth.

Christensen inquired about the need to revoke the dance permit obtained by Michael Stinchfield following his arrest. Chief Mannix will ask Captain Torres to look into the process to revoke the permit, but believes Stinchfield's business will never open.

Christensen inquired about the Compstat numbers. Chief Mannix replied that they have not been released yet for the month, but believes response times are holding flat.

Christensen inquired about additional observations of the effects of AB109 prisoner realignment bill. Chief Mannix stated they have seen several cases of crime reoccurrence following releases. He believes Chief Sanchez and Sherriff Brown still plan to hold a press conference after analysis has been complied.

Chief Mannix mentioned that they will be interview by Time Magazine regarding their "Coffee with a Cop" program, which has been very successful. The next event will be held at Good Cup Coffee on the Mesa

Christensen inquired about the status to move dispatch to the new location above Granada Garage. Chief Mannix stated that move is still planned. He will have Captain Torres send an email update on the project.
