**CONSENT CALENDAR**

**1. Approval Of Minutes**

The Golf Advisory Committee waived the reading, and approved the minutes of the meeting of October 11, 2017.

**ADMINISTRATIVE AND STAFF REPORT**

**2. Golf Course Performance**

Jesse Seguin provided a verbal report advising the committee that revenue in October fell below budget and prior year by 12% and 10% respectively. Aerification occurred earlier in October 2017 than in October 2016, and this is judged to have impacted play levels, along with an average high temperature of 80 degrees in October 2017, compared to 73 degrees in October 2016. High heat

is often a deterrent to golfers wishing to play. Staff is encouraged that the course conditions following aerification have recovered well.

### **3. Golf Maintenance Report**

Jesse Seguin provided a verbal report updating the Committee on course conditions and maintenance completed in October. Maintenance staff completed aerification and added sand to twelve bunkers on the course following inspection and customer feedback. Fairways have been aerified along with tees.

### **6. Home Club Reports**
