8. Harbor Laundry Facility Lease

RECOMMENDATION: That Harbor Commission:

- A. Accept the Selection Committee recommendation that Web Service Company, LLC, was being responsive to the Request for Proposals for the 161 square foot harbor laundry facility at 307 Shoreline Drive; and
- B. Recommend to City Council approval of a seven-year lease agreement with Web Service Company to provide and maintain commercial laundry machines for the harbor laundry facility with percentage rent of 90% of gross receipts in excess of \$374 per month.
- 9. Request from Commissioner Will Anikouchine to review and discuss the FY 2010 Budget recommendations approved by the Harbor Commission on April 16, 2010, together with Waterfront staff recommendations, which will be presented to the City Council as part of the City's Budget process.
