## **COMMISSION/STAFF COMMUNICATIONS**

Commissioner Sloan asked about the Work Inc. contract increase of \$31k. Director Riedman said the increase was due to the increase of minimum wage and next year will be a similar increase for the same reason.

Commissioner Spicer asked about the process and decision for allowing cruise ship passengers to make landfall if health is an issue. Mick Kronman described the established protocol followed when we receive reports of ill passengers aboard a cruise ship. Before passengers disembark, the Medical Director of the Santa Barbara County Department of Public Health meets the head of the cruise liner's medical staff, onboard the vessel, in order to examine the protocols and procedures with diagnosing and quarantining patients, and screening procedures for passengers designated to disembark.

Commissioner Kelly questioned the low dollar amount Fishermen prove as earnings every two years as part of the Commercial Fishing Berthing Policy, and if the City gets requests from fishermen to participate in the program in order to get a Slip Permit at a reduced rent. Mick Kronman said that there are fishermen who have been unable to meet the minimum requirements and have transferred the Slip Permit to new fishermen. Because the policy seems to be working, the earnings portion of the policy was not revised, but Staff is willing to work with the Commission at their request. Mick Kronman confirmed with Chair Cramer that all fishermen were mailed a copy of Item 6 Berthing Policy – Designated Commercial Fishing Slips

Commissioner Power made admirable mention of Mick Kronman's fun and interesting book on the local history of fishing.
