NOTICE OF A MEETING AND PUBLIC HEARING OF THE HISTORIC LANDMARKS COMMISSION TO CONSIDER PROPOSED AMENDMENTS TO THE CITY'S POTENTIAL HISTORIC RESOURCES LIST

Building(s) on your property have been identified as non-contributing to a potential historic district as part of a resource survey complete for the Lower Riviera area. Non-contributing buildings are located within the district boundaries but do not add to the historic or architectural qualities of the district, as they were constructed outside the period of significance or are no longer recognizable as such.

Although your property is not a historic resource in the potential historic district, being in the boundaries of the district affects property owners in a number of ways, including, but not limited to, new discretionary oversight on future alterations to structures within the district to ensure **compatibility** with the district as a whole.

The purpose of this notice is to advise property owners of a public hearing to consider the inclusion of properties identified as having historic significance for placement onto the City's Potential Historic Resources List (City's Potential List). Although your property will not be added to the list, it will be noted that your property is within the boundaries of a potential historic district. The Historic Structures Ordinance - Municipal Code Section 22.22.030 provides authority for the Historic Landmarks Commission to periodically review, amend and maintain a master list of potential historic resources within the City of Santa Barbara.

Additional Neighborhood Meeting Planned: Prior to the Commission hearing of June 19, 2013, the City will organize a neighborhood meeting with the purpose of providing property owners in the neighborhood with more survey information and the opportunity to answer questions. You will receive a separate notice of the neighborhood informational meeting with the time, date and location in a separate mailed notice.

At the Commission hearing to consider listing the properties on the City's Potential List, the property owner [or owner's representative] and City Staff shall be entitled to present any relative evidence, both oral and written, to establish whether the structure has appropriate potential for designation as a City Historic Resource. The decision to list a structure on the City's Potential List may be appealed to City Council in accordance with SB Municipal Chapter 1.30.

You are invited to attend this hearing and address your verbal comments to the Historic Landmarks Commission. Public comments will be allowed during review of the project by the HLC. Written comments are also welcome up to the time of the hearing, and should be addressed to the City Planning Division, P.O.
