SUBJECT: Update of the Historic Resources Potential and Designated Lists

For many years Staff has been working to update the Master Environmental Assessment Guidelines for Archaeological Resources and Historic Structures and Sites (January 2002) (MEA) City of Santa Barbara Potential Historic Structures/Sites list (Appendix C) and Designated Historic Structures/Sites lists (Structures of Merit and City Landmarks) (Appendix B).

The existing City of Santa Barbara Potential Historic Structures/Sites list (Potential List) has 593 records on it. The list is very outdated, in need of reformatting, edits and changes are needed since it was last printed in 2002. It is important that the database and list be accurate so correct information on historic resources can be shared with the public. The revisions to the Potential List include proposed deletions and additions and will result in a total of 545 records. The reasons for the changes in number of overall records are provided in detail below. Generally, the updates are necessary because the HLC has either: 1) previously approved or needs to approve the addition or deletion of records from the lists; 2) the Urban Historian has determined removal of structures is required (usually because the structure had been demolished or substantially altered), 3) recent status changes due to designations, 4) parcel or address revisions; and 5) other various errata corrections. The HLC has approved previous revisions to the Potential List by previous actions in 2007 and 2009.

The existing Designated Structures of Merit list contained 113 records and the existing Designated Landmarks list, both adopted in 2002, had 81 records. (These lists are combined in the current MEA- Appendix B. The revised Designated Structures of Merit list has 116 records and the revised Designated Landmarks list has 96 records on it. The changes in these two lists are provided in detail below. The changes to the Designated Structures of Merit list are due to HLC approved additions, the removal of duplicate entries (cross references are now provided), and new information in HSR. Changes in the Landmarks list are due primarily to designation actions of the City Council. Additional entries are made to cross reference properties with differing addresses.
