The Historic Landmarks Commission (HLC) will hold a public hearing to give the public an opportunity to be heard and offer comments early in the review process on architectural design related issues or development plan approval findings regarding the subject property below:

Project Description: **Proposal for the "as-built" installation of a stone pizza oven with a 7-foot chimney, barbeque, and counter in the interior setback of an existing two-residential development. A new 2-foot, 8-inch stone wall was added within 5 feet of the existing 3-foot, 9-inch sandstone wall on the front property line. The existing western lot line wall was refinished with stone. Staff Hearing Officer review is requested for an interior setback modification. This property is on the City's List of Potential Historic Resources.**

Public comments will be allowed for consideration by the HLC as part of the public hearing process. The HLC is the Commission appointed by the Council to review and make recommendations regarding the possible designation historic resources. Due to time constraints, individual comments may be limited to two minutes. Written comments are also welcome up to the time of the hearing, and should be addressed to the City Planning Division, P.O.
