Notice is hereby given that the Historic Landmarks Commission (HLC) of the City of Santa Barbara has selected the following resource for consideration as a Structure of Merit:

- 1. The Fairbanks House, 1720 Bath Street, a two-story Shingle style house (c. 1890)

You are invited to attend the hearing and address your comments to the HLC. The HLC is a Commission appointed by City Council for review of projects located within the El Pueblo Viejo district or involving City historic resources, and designation of historic structures. Due to time constraints, individual comments are typically limited to two minutes. Written comments are also welcome; mail to HLC Secretary, P.O. Box 1990, Santa Barbara, CA 93102-1990 or email to HLCSecretary@SantaBarbaraCA.gov. Please note that the HLC may not have time to consider written comments received after 10 a.m. on the day of the meeting.

The purpose of the public hearing will be to review the Staff Report and take public comment. The Commission will adopt a resolution that the structure be designated as a Structure of Merit.
