Notice is hereby given that the Historic Landmarks Commission of the City of Santa Barbara (HLC) has selected the following resources for consideration as City Landmarks:

1. **Craftsman Style Residence, "The Olives," 2121 Garden Street, APN 025-252-003, 1:45 p.m.**
2. **Our Lady of Sorrows Church, 33 East Sola Street, APN 039-072-007, 2:00 p.m.**
3. **Notre Dame School, 33 East Micheltorena Street, APN 027-232-014, 2:15 p.m.**

Public comments will be allowed during review of the designations hearings by the HLC. The HLC is a body appointed by the City Council to focus on neighborhood compatibility, aesthetics, architectural design issues, and designation of historic structures. Comments on the Staff Report and criteria qualifying the building for historic significance are welcome. Due to time constraints, individual comments may be limited to two minutes. Written comments are also welcome up to the time of the hearing and should be addressed to the City Planning Division, P.O. Box 1990, Santa Barbara, CA 93102-1990, or by e-mail to [HLCSecretary@SantaBarbaraCA.gov](mailto:HLCSecretary@SantaBarbaraCA.gov).

The purpose of the public hearing will be to review the Staff Reports and take public comment. The Commission will adopt resolutions to recommend to City Council that the structures be designated as City Landmarks.
