Notice is hereby given that the Historic Landmarks Commission of the City of Santa Barbara (HLC) has selected the following resource for consideration as a Structure of Merit:

1. **1809 Mira Vista Avenue, Tudor Revival style house constructed in 1925, APN 019-090-026**

You are invited to attend the hearing and address your comments to the HLC. The HLC is a Commission appointed by City Council for review of projects located within the El Pueblo Viejo district or involving City historic resources, and designation of historic structures. Due to time constraints, individual comments are typically limited to two minutes. Written comments are also welcome. Mail to HLC Secretary, P.O. Please note that the HLC may not have time to consider written comments received after 10 a.m. on the day of the meeting.

The purpose of the public hearing will be to review the Historic Structures Report and take public comment. The Commission will adopt a resolution that the structure be designated as a Structure of Merit.
