Notice is hereby given that the Historic Landmarks Commission of the City of Santa Barbara (HLC) has selected the following resources for consideration as Structures of Merit:

1. **212 Canon Drive, Tudor Style Residence constructed in 1929, APN 053-162-002**
2. **1306 Alta Vista Road, Craftsman Style Residence constructed c. 1923, APN 029-100-036**

You are invited to attend the hearing and address your comments to the HLC. The HLC is a Commission appointed by City Council for review of projects located within the El Pueblo Viejo district or involving City historic resources, and designation of historic structures. Due to time constraints, individual comments are typically limited to two minutes. Written comments are also welcome; mail to HLC Secretary, P.O. Box 1990, Santa Barbara, CA 93102-1990 or email to HLCSecretary@SantaBarbaraCA.gov. Please note that the HLC may not have time to consider written comments received after 10 a.m. on the day of the meeting.

The purpose of the public hearing will be to review the Staff Reports and take public comment. The Commission will adopt resolutions that the structures be designated as Structures of Merit.
