The Historic Landmarks Commission (HLC) will hold a public hearing to review architectural design-related issues or development plan approval findings regarding the subject property below:

Project Description: **Proposal to demolish an existing 1,300 square foot office building and**

**construct a new 3-story, 15-room hotel and two-unit apartment building, for a total 10,890 square feet of hotel/residential space. Parking would be provided on the first level of the building with a 7,102 square foot covered parking garage, and would designate 16 spaces for the hotel, 4 spaces for the apartments, 1 additional space, and 3 bike spaces. The 15 hotel rooms would be on the second and third level of the building, and the two apartment suites on the third level. The project includes a voluntary lot merger of two parcels, and the use of minor and small addition non-residential floor area allocations. A transfer of existing development rights is proposed from 3714-3744 State Street. Project requires Development Plan approval by Planning Commission for the new nonresidential floor area.**

You are invited to attend the hearing and address your comments to the HLC. The HLC is a Commission appointed by the City Council to review projects located within the El Pueblo Viejo district or involving City historic resources. Due to time constraints, individual comments are typically limited to two minutes. Written comments are also welcome. Mail to HLC Secretary, P.O. Please note that the HLC may not have time to consider written comments received after 10 a.m. on the day of the meeting.

If the project requires approval by the Planning Commission or the Staff Hearing Officer, you will receive a notice for that public hearing. The scope of this project may be modified under further review. To be informed of future hearings, you may:
