Notice is hereby given that the Historic Landmarks Commission of the City of Santa Barbara (HLC) has selected the following resources for consideration as City Landmarks:

1. **Live Oak Dairy Building, 901 North Milpas Street (also known as 900 Philinda Avenue), APN 029-313-015, 1:45 p.m.**
2. **Kem Weber Building, 1301-1303A State Street, APN 039-131-013, 039-131-014, and 039-131-015, 1:55 p.m.**
3. **Ygnacio House, 214 East De La Guerra Street, APN 031-082-002, 2:05 p.m.**
4. **Arnoldi's Restaurant, 600 Olive Street, APN 031-171-006, 2:15 p.m.**

You are invited to attend the hearing and address your comments to the HLC. The HLC is a Commission appointed by City Council for review of projects located within the El Pueblo Viejo district or involving City historic resources, and designation of historic structures. Due to time constraints, individual comments are typically limited to two minutes. Written comments are also welcome. Mail to HLC Secretary, P.O. Please note that the HLC may not have time to consider written comments received after 10 a.m. on the day of the meeting.

The purpose of the public hearing will be to review the Staff Reports and take public comment. The Commission will consider resolutions to recommend to City Council that the structures be designated as City Landmarks.
