The Historic Landmarks Commission (HLC) will hold a public hearing to review architectural design-related issues or development plan approval findings regarding the subject property below:

Project Description: **This residence is on the City's List of Potential Historic Resources, as it is**

**eligible to be designated a Structure of Merit. The proposal is for an approximately 227 square foot first-floor rear addition, and an approximately 478 square foot rear-basement addition/remodel, to an existing 2,203 square single-unit residence. The project includes adding a new detached 518 square foot rear carport, and 192 square foot rear trellis. The proposed total of 3,246 square feet on an 8,625 square foot lot is 97% of the maximum required floor-to-lot-area ratio. Project requires a Modification with the Staff Hearing Officer for the proposed open yard.**

You are invited to attend the hearing and address your comments to the HLC. The HLC is a Commission appointed by the City Council to review projects located within the El Pueblo Viejo district or involving City historic resources. Due to time constraints, individual comments are typically limited to two minutes. Written comments are also welcome. Mail to HLC Secretary, P.O. Please note that the HLC may not have time to consider written comments received after 10 a.m. on the day of the meeting.

If the project requires approval by the Planning Commission or the Staff Hearing Officer, you will receive a notice for that public hearing. The scope of this project may be modified under further review.
