2. **Live Oak Dairy Building, 901 North Milpas Street (also known as 900 Philinda Avenue), APN 029-313-015, 1:55 p.m.**
3. **La Arcada Building, 1110-1114 State Street, APN 039-232-009, 2:05 p.m.**

You are invited to attend the hearing and address your comments to the HLC. The HLC is a Commission appointed by City Council for review of projects located within the El Pueblo Viejo district or involving City historic resources, and designation of historic structures. Due to time constraints, individual comments are typically limited to two minutes. Written comments are also welcome. Mail to HLC Secretary, P.O. Please note that the HLC may not have time to consider written comments received after 10 a.m. on the day of the meeting.

The Commission will consider resolutions to recommend to City Council that the structures be designated as City Landmarks.
