Notice is hereby given that the Historic Landmarks Commission of the City of Santa Barbara (HLC) has selected the following historic resource for consideration as a Structure of Merit:

- 1. 3014 Paseo Del Refugio, a Spanish Colonial Revival style house constructed in 1927, APN 053-201-011**

You are invited to attend the hearing and address your comments to the HLC. The HLC is a Commission appointed by City Council for review of projects located within the El Pueblo Viejo district or involving City historic resources, and designation of historic structures. Due to time constraints, individual comments are typically limited to two minutes. Written comments are also welcome. Mail to HLC Secretary, P.O. Please note that the HLC may not have time to consider written comments received after 10 a.m. on the day of the meeting.

The purpose of the public hearing will be to review the Staff Report and take public comment. The Commission will adopt a resolution that the historic structure be designated as a Structure of Merit.
