**PROJECT DESCRIPTION:** The Folk Victorian residence constructed in 1904 is a designated Structure of Merit: Huffman Residence. Proposal to install new ornamental fencing along the property lines bordering Brinkerhoff and Cota Streets. A Minor Zoning Exception is required for the fence to be 48 inches tall within the first ten feet of the front lot line.
