PROJECT DESCRIPTION: This is a revised project description. Flying A Film Studio, constructed in 1913, is a designated City Landmark. Proposal to demolish the existing non-historic garage to accommodate accessible parking, and provide an additional paved parking space. Site improvements include a new walkway, new handrails at the exterior stairs, and replacement of entry landings.
