**PROJECT DESCRIPTION:** This is a revised project description. Proposal for a new two and three-story residential condominium project comprised of seven units with private roof decks for four units. The site is currently developed with a three-story 13,183 square foot commercial building and 40 parking spaces. The project includes a 3-stack puzzle lift containing 17 spaces to serve the existing commercial building, another puzzle lift system containing 11 spaces, and seven surface parking spaces.
