PROJECT DESCRIPTION: This site is located in El Pueblo Viejo Landmark District and adjacent to a designated City Landmark at 713 Santa Barbara Street. The site is currently developed with commercial office space and a manufacturing/storage building. Proposal to construct a 1,200 square foot ground level office addition at the rear dock under an existing roof canopy, and permit an existing 233 square foot rear utility enclosure. Site improvements include reconfiguration of the existing parking lot paving, including new Americans with Disabilities Act (ADA) path of travel walkways, and associated parking lot landscaping.
